Spam is considered any irrelevant or inappropriate messages that attempt to direct forum users to another website for the purpose of solicitation, dissemination of propaganda, or an attempt to collect personal data.

Residents nor outside advertisers may use these forums as a vehicle for promoting non-profit, for profit, or any other type of business-related items.
